BAI Constitution provides that:

- Centre should send the list of such paid members to headquarters with the share of the headquarters on or before 15th October of every year to enable headquarters to continue mailing 'Indian Construction' journal.
- 'Patron Members' are required to pay annual subscription of Rs.200/- towards 'Indian Construction' journal.
- A list of 'Patron Members' along with their subscription towards 'Indian Construction' journal should also be sent to enable headquarters to continue mailing 'Indian Construction' journal to them.
